PUBLIC WORKS DEPARTMENT

Transportation

1st Street Mill and Fill – On 1st St. N east of 13th Ave. the top 50 mm of asphalt were milled off and 75 mm of asphalt was placed. This road renewal will result in a smooth ride along 1st St. N for years to come.

Heyes Street Storm sewer – An additional storm sewer catch basin, a storm main and an outfall were added at the north end of Heyes St. This will prevent flooding at the north end of Centennial Dr. N and prevent rainwater from backing up and infiltrating the sanitary sewer system.

Lowering Manholes – With the late fall, crews were able to lower more than 25 manholes around town, making it easier to plow snow off the roads all winter long.

Sanding Streets – The sanding truck has been out around town spreading sand at intersections and on hills to ensure everyone can get around safely.

Cleaning Catch Basins – Select catch basins have been cleaned out to prevent gravel and other debris from entering the storm sewer system.

Pothole Patching – Several areas of deteriorated pavement around town were cut, removed and replaced with new asphalt. This prevents surface water from entering the pavement substructure which prevents further deterioration.

Utility

Currie Road N – Water and sewer mains were extended along Currie Road N to provide service to new developments in the area.

Meter Installs – Finishing the remaining meter installs, which allows all of the water meters in town to be read in a couple of hours instead of 2 to 3 weeks.

Flushing Sanitary Sewers – The sanitary sewer flushing program continued this fall. The program is designed to remove built up residue in the pipes, allowing smooth flows throughout the system and preventing backups.

Abandoned Old Services – Water lines at the old town trailer court were excavated, cut and capped so that the property will be ready for future development.

Councillor's Corner

I thought it would be appropriate to bring our Swan Valley Community up to date on what is happening in the local medical world. The G4 (Town of Swan River, Municipality of Swan Valley West, Municipality of Minitonas-Bowsman and the Rural Municipality of Mountain), the Recruit/Retain Medical Committee, Prairie Mountain Health (PMH), Province of Manitoba, doctors and nurses, Leisa Lukie and the primary clinic staff are all actively recruiting doctors, physiotherapists and nurses. Our catchment area has approximately 16,000 residents and some suggest that means we need 16 doctors with appropriate support staff and technology. Our new contingent of doctors are actively recruiting their peers and they and I remain positive. Our concept being entertained is bringing resident doctors to the clinic to do part of their training locally. This hopefully

would lead to them returning to start their practices here.

Accommodations for medical professionals remain a problem but our economic development entity (RISE) has made this a priority so we hope for progress here.

We are aware that there are 12 resident doctors training in Dauphin and we will be inviting them to come to our Valley for a tour to show them the many amenities we share. We will also go to Dauphin to meet with them to discuss their plans and our opportunities.

Requests for specific medical technologies keep coming in and we believe many will come to fruition through the remarkable support of our Lions Clubs, Hospital Foundation and other service groups. Having the specific tools that they were trained to use is a big attraction to medical professionals. PMH advises us that partial obstetrics services for low risk births is a goal that is closer to being accomplished than before. Doctors and nurses are being trained on a regular basis for these procedures.

At a meeting this fall with Wayne Heide, Administrative Director, Manitoba Office of Rural and Northern Health and Dr. Don Klassen, Medical Director (ORNH) we were encouraged by both men who advised us we were on the proper path regarding recruiting and retaining activities.

Great news happened recently when the G4 announced they all agreed on extended funding for medical professionals recruitment for another 3 years. Our Valley municipal leaders are committed to improving health care. Also discussed with medical professionals was the medical College Admissions Test (MCAT) and the interview process for prospective doctors. At the moment rural students get special bonus points up to 13% more credit over urban students. Urban students do not appreciate this. We have been encouraged to not take our "foot off the gas pedal" as complacency is dangerous. The bottom line is those communities that are actively engaged in the recruiting process are more successful than those not doing so.

Yes we all agree this is a Provincial Government responsibility but our success can be attributed to our local Valley groups, PMH and government's support.

The College of Physicians and Surgeons accepts annually 110 students, only 5 from outside of Manitoba.

Our local community people are extremely important in medical professionals' decisions to come to our Valley.

Some suggest our towns, social activities, fishing trips etc. are more important than the hospital work when it comes to decisions as to where to start their practice. So a big "THANK YOU" to the many people who help out in so many different ways! If you belong to a church group, service club, community group etc, please don't hesitate to ask one of these young people to attend one of your activities. Developing roots for spouses and medical professionals are all important. We are also working with the Regional School (SVRSS) to establish protocols to identify potential medical professionals and encourage them to return to our Valley.

Dr. Savanna McKay will start here in July 2017.

The Hospital Foundation has also been very cooperative in monetary support for different medical requests.

If you know of any Valley students in a medical school please let us know so we can contact them.

Our local doctors certainly should be commended for their dedication. Not only do they work in the clinic but also work in emergency, and do dialysis plus chemotherapy work at the hospital; very long days. We appreciate their significant contribution.

Leisa Lukie and her team at the clinic are to be commended for their exemplary commitment to our Valley health care.

At the recent Annual Association of Manitoba Municipalities (AMM) Convention we had the pleasure of meeting with the Honourable Kelvin Goertzen, Minister of Health. Your Town council was frank in its requests for support and also complimented him for staying involved. He was very appreciative of our input. We also met with Beth Beaupre, ADM to Minister Goertzen to discuss future recruiting processes.

In the continued good news department Dr. Rafiq Andani at the Primary Care Clinic has been arranging for three of his peers from the Northern Remote Program to visit our community. He and I are working at when and how to bring them to the Swan Valley. All three doctors will be available to work July

2017. We will be asking our partners to plan activities to showcase our many Valley amenities.

Recently I chatted with Courtney Bell from Bellsite and Amanda Woodson from Minitonas; both in medical schools. We will be meeting with them to discuss plans to get them both to return to practice medicine at home.

Are we where we want to be yet? No but we are certainly progressing rapidly thanks to all of the supports we have. I can't imagine how bad it would be if we did not have this new group of young doctors who have committed to our Valley.

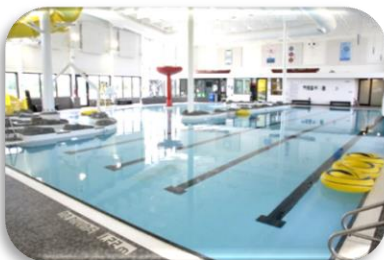

FIRE DEPARTMENT

ELECTRICAL SAFETY TIPS

- Have all electrical work done by a qualified electrician.
- When you are buying or remodeling a home, have it inspected by a qualified electrician.
- Only plug one heat-producing appliance (such as a coffee maker, toaster, space heater, etc.) into a receptacle outlet at a time.
- Major appliances (refrigerators, dryers, washers, stoves, air conditioners, etc.) should be plugged directly into a wall receptacle outlet. Extension cords and plug strips should not be used.
- Arc fault circuit interrupters (AFCIs) are a kind of circuit breaker that shuts off electricity when a dangerous condition occurs. Consider having them installed in your home. Use a qualified electrician.
- Use ground fault circuit interrupters (GFCIs) to reduce the risk of shock. GFCIs shut

off an electrical circuit when it becomes a shock hazard. They should be installed inside the home in bathrooms, kitchens, garages and basements. All outdoor receptacles should be GFCI protected.

- Test AFCIs and GFCIs once a month to make sure they are working properly.
- Check electrical cords to make sure they are not running across doorways or under carpets. Extension cords are intended for temporary use. Have a qualified electrician add more receptacle outlets so you don't have to use extension cords.
- Use light bulbs that match the recommended wattage on the lamp or fixture. There should be a sticker that indicates the maximum wattage light bulb to use.

IMPORTANT REMINDER

Call a qualified electrician or your landlord if you have:

- Frequent problems with blowing fuses or tripping circuit breakers
- A tingling feeling when you touch an electrical appliance
- Discolored or warm wall outlets
- A burning or rubbery smell coming from an appliance
- Flickering or dimming lights
- Sparks from an outlet

The New Municipal By-Law

Enforcement Act allows municipalities to enforce parking tickets and other by-law violations through the use of administrative penalties and non-judicial adjudicators instead of relying on limited Provincial Court resources. The Town is currently drafting a by-law to comply with this new Act. The goal is to create a simple, fair, and cost effective system to enforce by-laws while resolving disputes in a way that promotes understanding and compliance. The majority of the violations that will be enforced this way will relate to parking restrictions and community liveability by-laws. A penalty notice is issued if a by-law enforcement officer believes that there has been a by-law violation. The notice will include the relevant information relating to the violation and the amount of the administrative penalty that is owed. You may dispute the violation by contacting the Town office. A dispute is first reviewed by a screening officer who will review the information contained on the penalty notice and any additional information you may wish to provide. The screening officer will then determine if the penalty should be upheld, cancelled or in some cases varied. If you disagree with the screening officer's decision, you can request adjudication by a provincially appointed adjudicator. The adjudicator will review the screening officer's decision and any additional information that the adjudicator considers relevant. The adjudicator's decision is final and not subject to any appeal.

GET READY FOR FOREST TENT CATERPILLARS

2016 saw a significant amount of defoliation in the spring. Expect a similar amount this spring.

Things to know:

Currently in egg stage, they will hatch near bud break time (mid-late May) Caterpillars will feed through May-June (4-5 weeks)

Moths will emerge for approx. 1 week in July.

Forest Tent Caterpillars infest in 12-15 year cycles

Outbreaks typically last 2-3 years, Currently Manitoba is in Year 2.

Can last from 2-9 years, though heavy defoliation rarely occurs more than 2 years at a given site.

Options for small area or individual trees:

Do nothing as most trees typically survive defoliation

Place barriers on trees

Remove egg masses before they hatch

Remove larvae when congregated

Use of insecticides

The Town currently has no plans or budget aside for fighting the forest tent caterpillars, if we were to do anything, only the parks and Town owned trees would be treated which overall are a small percentage of the trees in Town, we would not be treating any trees on private property.

BUILDING PERMITS

All property owners planning construction projects are required to contact the town office for development applications and building permits prior to any work taking place. In general, permits are required for new buildings and large renovations, garages, sheds over 120 sq.ft., decks, fences, demolitions and fire pits. We appreciate all inquiries and will provide any information we have on proper building methods. No permit is required for surfacing driveways or placing sidewalks within property limits but we need to be contacted in case town utilities are affected. Remember to call all utilities before beginning excavation projects.
